Subject: Summary Report of Swimming Pool Lift Tests per ADA 1009.2, for SR Smith Model No. 370-0000, Splash Extended Reach Aquatic Lift.

This summary contains the limited results of the detailed report that was prepared as an outcome of the testing performed on a sample of swimming pool lift identified as **SR Smith Model No. 370-0000, Splash Extended Reach Aquatic Lift,** which was tested according to the American's with Disabilities Act (ADA) standard 1009.2. All the tests were performed under simulated pool environment and on site at SR Smith, LLC facility, located in Canby, Oregon.

## Scope of the Testing (Work)

The testing was conducted under simulated pool environment to ascertain that the pool lift (tested in as-mounted condition by SR Smith) complied with ADA Standard 1009.2.

## **Mounting Apparatus**

A platform made of plywood simulating a typical pool deck was set up by SR Smith, and was used to mount the pool lift. The pool lift to be tested was mounted into a simulated concrete instillation at a typical installation distance (18" on center) to the simulated pool wall.

## **Tests Conducted and Measurements Made**

A test protocol to include all the measurements and tests as detailed in the standard was prepared and tests were performed by strictly following the standard protocol and by using calibrated instruments. All the measurements (where applicable) were performed by using the deck to mimic the pool, and the lifts mounted on it.
